

# Cookie Policy

Who is the administrator?

Cookies are personal data according to the GDPR regulation. The administrator of your personal data is BlueLake Hub FZCO, Premises No: DSO-IFZA, IFZA Properties, Dubai, Silicon Oasis, UAE, Registration number: DSO-FZCO-35081, License number: 37168.

It operates the websites <https://www.darkoptionflow.com/> and some other websites. We are in the position of administrator in relation to your personal data (including cookies): we determine how personal data will be processed and for what purpose, for how long and we select any other processors who will help us with the processing.

What are cookies?

Cookies are small data files that are stored on your computer or mobile device when you visit a website. Cookies are widely used by online service providers because they facilitate and expedite interaction between users and websites, improve ad targeting and relevance, collect analytics data, and generally provide a better experience for site visitors.

The cookies set by the website (DarkOptionFlow) are called "first party cookies". Cookies set by parties other than the website or platform owner are called third-party cookies. Third-party cookies allow you to provide special features, such as advertising, interactive content, or analytics. Third parties that set these cookies may subsequently recognize your computer or device both when visiting the website, mobile application or platform in question, but also when visiting some other websites or mobile applications.

The information collected through cookies does not allow us to identify your name, contact information or other personally identifiable information unless you choose to provide it to us.

Why do we use cookies?

We use first-party and third-party cookies for several reasons. Some cookies are required for technical reasons for our website to work, and we refer to them as “basic” or “essential” cookies. Other cookies also allow us to track and target the interests of our users in order to improve the experience on our website or the targeting of our ads. Third parties provide cookies through our websites for analysis and other purposes.

What cookies do we record?

When browsing our website, we record your IP address, how long you stay on the page, which page you come from and if you come thanks to one of our affiliate partners. We consider the use of cookies to measure website traffic, affiliates and customize the display of websites as our legitimate interest of the administrator, as we believe that thanks to this we can offer you even better services.

If you visit our website and have cookies enabled in your browser, we perceive a legitimate interest in tracking which pages you visit on our website and then improve the targeting and relevance of our Facebook ads, for a maximum of 1 year from your last site visits. If you do not wish to see our ads on Facebook, you can cancel the display of our ads directly on Facebook via this guide, or turn off cookies in your browser, or change your ad serving preferences on the Ads Preferences page.

Who do we use to process cookies?

How to refuse storing cookies?
